Exhibit Guidelines: Entries will not be accepted when no class is listed. Current Year Canned Goods Only. Canning jars must be used (no salad dressing jars allowed). Cans must have outer ring. Cans with rusty lids or rings will be disqualified. Complete exhibits must be left on display (unless otherwise noted). Anyone removing exhibits before Friday will forfeit premium.

Judging Time: Saturday, July 25 at 2 PM. Area must be clear of exhibitors.

Release of Exhibits: Exhibits must be picked up on Friday, July 31, 2009 between 8 AM and 10 AM.

Rules:

1. The General Rule and Regulations of the Fair apply in this department.
2. Junior Open entries are open to boys and girls who are 8 years of age or in the third grade by September 1, 2008 and not yet 19 years of age, on or before September 1, 2008. Adult Open is open to anyone of ages 19 and over.
3. Premium checks will be released on Friday, July 31, 2009 between 8 AM and Noon. Exhibitor must sign a Premium statement to receive check.
