Stall Reservations:	Stall Reservations must be made with the Superintendent by July 15, 2009. Stall assignments will only be made by the Horse Superintendent.	
Entries Taken:	Entries and pay fees by Wednesday, July 29, 2009, 12 Noon, at the fair office.	
Number of Class Entries:	Entries limited to two (2) entries per class per exhibitor, unless noted otherwise.	
Arrival of Animals:	One horse from each exhibitor needs to be on the fairgrounds by 8 PM, Tuesday, July 29, 2009, to show in the Junior Open and Lawrence County Youth Only.	
Bedding:	Exhibitor is responsible for providing bedding. All stalls and tie-outs are to be cleaned before animals leave the fairgrounds.	
Livestock Health Requirements:	Health certificates are required as set forth in the State of Illinois 2009 Livestock Exhibition Regulations (Please read). Certificates will be checked at sign-in.	
Livestock Premises ID:	Premises Registration is voluntary to exhibit horses at the 2009 county fair.	
Ownership Dates and Paper:	Lease or ownership papers will be checked by the superintendent. Horses must be in sole possession and personally cared for by the exhibitor by June 1, 2009. None of these horses can be exhibited at any other fair after June 1, 2009, by any other exhibitor.	
Release of Animals:	Horses will be released from the fairgrounds on Friday, July 31, 2009 after 9 PM.	
Premiums Checks:	Premiums Checks will be available Saturday, August 1, 2009 at 11 AM. Exhibitor must sign a Premium Statement to receive check.	

Rules:

1. The General Rule and Regulations of the Fair apply in this department.
2. Entries are open to boys and girls who are 8 years of age or in the third grade by September 1, 2008 and not yet 19 years of age, on or before September 1, 2008.
3. Animals not presented in the show ring at the time of show will forfeit their right to show.
4. During judging, no one is allowed in the show ring except Judge(s), Exhibitors, and Ring Assistants (who are selected by the superintendent).
