<b>Total Premiums Offered:</b>	\$3060.00	
<b>Exhibitor Fee:</b>	\$0.00	
<b>Stall Rent:</b>	\$10.00 per head. Number of Animals will be checked against entry form.	
<b>Stall Reservations:</b>	Stall Reservations must be made with the Superintendent by July 15, 2010. Stall assignments will only be made by the Horse Superintendent.	
<b>Entries Taken:</b>	Entries and pay fees by Wednesday, August 4, 10-11 AM, at the fair office.	
<b>Number of Class Entries:</b>	Entries limited to two (2) entries per class per exhibitor, unless noted otherwise.	
<b>Exhibiting Rule:</b>	All entries must be exhibited by the exhibitor. Exhibitor owning the animal must be present and in the show ring showing the animal in their classes. ONLY EXCEPTION: Exhibitor having 2 entries in same class.	
<b>Arrival of Animals:</b>	One horse from each exhibitor needs to be on the fairgrounds by 8 PM, Tuesday, August 3, 2010, to show in the Junior Open.	
<b>Bedding:</b>	Exhibitor is responsible for providing bedding. All stalls and tie-outs are to be cleaned before animals leave the fairgrounds.	
<b>Livestock Health Requirements:</b>	Health certificates are required as set forth in the State of Illinois 2010 Livestock Exhibition Regulations (Please read). Certificates will be checked at sign-in.	
<b>Livestock Premises ID:</b>	Premises Registration is voluntary to exhibit horses at the 2010 county fair.	
<b>Ownership Dates and Paper:</b>	Lease or ownership papers will be checked by the superintendent. Horses must be in sole possession and personally cared for by the exhibitor by June 1, 2010. None of these horses can be exhibited at any other fair after June 1, 2010, by any other exhibitor.	
<b>Release of Animals:</b>	Horses will be released from the fairgrounds on Friday, August 6, 2010 after 9 PM.	
<b>Premiums Checks:</b>	Premiums Checks will be available Saturday, August 7, 2010 after 5 PM. Exhibitor must sign a Premium Statement to receive check.	

### **Rules:**

1. The General Rule and Regulations of the Fair apply in this department.
2. Entries are open to boys and girls who are 8 years of age or in the third grade by September 1, 2009 and not yet 19 years of age, on or before September 1, 2009.
3. Animals not presented in the show ring at the time of show will forfeit their right to show.
4. During judging, no one is allowed in the show ring except Judge(s), Exhibitors, and Ring Assistants (who are selected by the superintendent).
