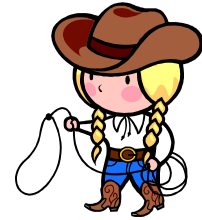




2010 Little Miss Cowgirl & Mister Cowboy Contest

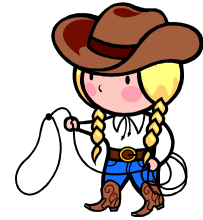

Each participant must pay a non-refundable \$5.00 entry fee by 6:00 Day of event.
